- ❑ COP recruited and reported **-August 2015 - 1st three Months contract to November 2015.**
- ❑ Seconded from the **Norwegian Refugee Council's (NRC) roster of experts NORCAP.**
- ❑ Secondment **financed by the SAI Norway (OAGN)**
- ❑ **Positive achievements** by the Coordinator Community of practice within this one month.
- ❑ **Challenge** –funds needed funds to extend operations of COP to at least one full year
